2. While SELLER has taken certain precautions to maintain the cat/kitten in a state of general good health, no guarantee and no warranty as to fitness and health is being made by SELLER to BUYER regarding said cat/kitten.
3. The BUYER shall have the option to have each purchased cat/kitten examined by a veterinarian of the BUYER’S choice. If the BUYER is dissatisfied by reason of said veterinarian’s examination as to any health condition of the purchased cat/kitten, then the BUYER may return the cat/kitten within 48 hours after signing this Agreement along with the veterinarian’s examination report and the SELLER shall refund the monies paid by BUYER. In no event shall the SELLER be liable for any veterinarian, travel or other expense incurred by BUYER.
4. BUYER hereby expressly acknowledges that no representations or warranties by SELLER as to the health of any cat/kitten have been relied upon by BUYER and that BUYER’S exclusive remedy is contained within this document.
5. Accordingly, BUYER hereby releases SELLER from any and all damages, causes of action, claims and controversies relating to or arising from the health condition of any cat/kitten, excepting only that BUYER may receive a refund of the paid purchase price as provided hereinabove.
6. BUYER hereby expressly indemnifies SELLER from any and all claims, causes of action, and damages, which may be brought or recovered by third parties to whom BUYER has exposed or transferred the cat/kitten.
